7. The setting up of the Office should not violate any Model Code of Conduct.
8. The Office should have sufficient Fire Safety Materials.
9. The organizer shall ensure to provide space for movement of Ambulance, Police Vehicle, Fire Tender.
10. The permission may be cancelled or revoked at any time, if, deemed fit by the undersigned.
